

- Honoring your colleagues at the Awards Banquet in the evening.


Fun for the entire family

VMS PARTNERSHIP TO HELP MEMBERS WITH VERMONT HEALTH CONNECT INSURANCE ENROLLMENT

Do you have questions about how the new Vermont Health Exchange will affect the health insurance benefits your practice provides its employees? Confused about the options available to you and your staff?

Luckily, the Vermont Medical Society can help you make informed decisions as Vermont transitions to Vermont Health Connect.

Through a grant VMS received in partnership with the Vermont Businesses for Social Responsibility and the Vermont Retail Association, a team of navigators has been made available to VMS members. The navigators are trained to provide simple, direct, and useful information to small businesses, including physician practices, in order to help them make timely decisions as Vermont transitions to Vermont Health Connect.

“All physician practices with less than 50 employees will have to go through the exchange to insure their employees, so the move to Health Connect will definitely be a change for many practices,” said Colleen Magne, VMS’s business manager and leader on the project. “They’ll need to explore their options with the new insurance offerings and requirements and the navigators are specially trained to help them with that.”



VMS FOUNDATION TO EXPLORE PHYSICIAN LEADERSHIP DURING ANNUAL MEETING SESSIONS

The Vermont Medical Society Education and Research Foundation will explore the important topic of the role of physician leadership in health care reform with a trio of programs during the VMS annual meeting weekend.

Kicking things off will be a discussion titled Policy, Politics, Advocacy & Public Service: Can Physician Leaders Really Make a Difference? taking place Friday, Oct. 18, at 3 p.m.

Exploring the experiences of Maine's Hanley Center and Brandeis University's Physician Leadership programs, the goal of the session will be to hear Vermont physicians, regional and national leaders discuss why physicians need to be involved in the current health policy debates, what skills they will need to be effective leaders. Most importantly, the session will be a generative discussion about establishing a Vermont program for physician executive leaders.

Panelists will include:

- Maroulla S. Gleaton, M.D., partner, Atlee Gleaton Eyecare, past president, Maine Med. Assoc.
- James Harnar, executive director, Daniel Hanley Center for Health Leadership

- Joshua Plavin, M.D., medical director, Gifford Medical Center
- Michael Rouse, M.D., chief hospitalist, chair of medicine, Northeastern VT Reg. Hosp.

Interested physicians and their administrative colleagues will find value in the session and are encouraged to attend.

On Saturday morning, the Foundation will facilitate a CME session that presents the research findings of Joshua Plavin, M.D., of Gifford Medical Center and Michael Rouse, M.D., of Northeastern Regional Hospital.

Their research outlines physician opinion on key issues for the Green Mountain Care Board to consider when developing a statewide Health Resource Allocation Plan for Vermont. The goal of this session is to get input from the VMS membership on the draft recommendations based on research to date, with a formal presentation to be made to the Green Mountain Care Board in November. The draft recommendations will likely initiate a lively discussion and be of interest to anyone potentially affected by a redesigned statewide delivery system.


A second session Saturday morning will feature a panel discussion about key roles for physicians in this time of transition in the health care delivery system, encouraging audience participation on the topic.

The panel will include Anya Rader Wallack PhD., a principal architect of Vermont's health care reform act; Jon Chilingirian PhD., a national and international authority on physician leadership; Maroulla Gleaton, M.D., a physician leader in Maine and Todd Moore, Senior Vice President, Accountable Care and Revenue Strategy, FAHC.



VMS MEMBERSHIP TO VOTE ON SIX PUBLIC POLICY RESOLUTIONS AT OCT. 19TH ANNUAL MEETING

The VMS Council has endorsed six resolutions ranging from alleviating the burden of quality reporting and supporting physician leadership, to improving the transition of care and setting standards for investigations conducted by the Vermont Board of Medical Practice.

The resolutions will now be voted upon by VMS members at the Society's Oct. 19th, annual meeting at the Basin Harbor Club in Vergennes, Vt. All VMS members are invited and encouraged to attend.

The process of developing the resolutions, which will form the basis of the organization's public policy efforts in 2014, began last spring with the distribution of the annual member survey. The survey's results were then used to inform discussion during the annual planning retreat held in August. VMS staff, working in consultation with the Council, the drafted resolutions based on the retreat's overriding themes and topics.

The six resolutions endorsed by the Council were:

Electronic Health Records and the Medical Record

Encourages Vermont's Congressional delegation to support the efforts of the Health Story Project to ensure that health information exchange standards go beyond a narrow, common data set to encompass the common types of medical records. Also calls for Electronic Health Records and other communication applications to respect the clinical voice and emphasize the medical record as a critical element in providing high quality care to patients.

Advances in Primary Care and Public Health Integration through Population Health

Calls for increased integration of efforts between public health and primary care to better address the root causes of illness, prevent additional cases of disease, and to make the default choices of individuals healthy ones. Seeks to accomplish this by committing VMS to work with numerous organizations and government agencies to implement the set of principles developed by the Institute of Medicine that they deem essential for successful integration, such as:

- A shared goal of population health improvement;
- Community engagement in defining and addressing population health needs;
- Aligned leadership;
- Sustainability, including shared infrastructure; and
- Sharing and collaborative use of data and analysis

Burden of Quality Reporting

Seeks to address the amount of time physicians spend dealing with quality reporting requirements by recommending the elimination of reporting requirements where there is a lack of evidence supporting their benefits and identifying ways to standardize the definitions and calculations for quality metrics used by the federal and state government entities, insurance payers, and others.


Support for Physician Policy Involvement and Physician Leadership Education

Seeks to capitalize on physicians' unique qualities that are critical for health care reform leadership to ensure that physicians have opportunities to be actively involved in forming policy in all arenas of health care reform. Additionally, the resolution calls for the portion of hospital budgets allocated by the Green Mountain Care Board for staff engagement in health care reform initiatives be used in part to support physician leadership, with special emphasis on Vermont Medical Society Education and Research Foundation efforts to have the training and education they need to function effectively as leaders in the health care reform environment.

Improving Transition of Care

Recognizes that the U.S. health care system often fails to meet the needs of patients transitioning from one care setting to another (i.e., hospital, home or a long-term care facility), and that care is frequently rushed, responsibility is fragmented, and

VMS POLICY RESOLUTIONS

(Cont'd from pg. 6) there is often little communication between care settings and multiple providers. The resolution calls for improved transition of care by resolving VMS to work the physician community and payors to educate on the use of the transition of care codes and improving care coordination, providing better incentives to ensure patients are seen in a physician's office, rather than be at risk for readmission, and encouraging precise and meaningful discharge summaries.

Investigation Standards for the Vermont Board of Medical Practice


Citing physician concerns that investigators from the Vermont Board of Medical Practice (VBMP) sometimes arrive unannounced at practices and request copies of patients' records, the resolution calls for the VBMP to establish by rule procedures for investigations of alleged unprofessional conduct, as well as:

- Providing meaningful notice of unprofessional conduct charges to licensees and a meaningful opportunity to respond to complaints;
- Adopting clear and transparent standards for the use and disclosure of patients' medical records requested in the course of an investigation of a licensee; and,
- Amending the physician license profile law to require the VBMP and Department of Health to remove any charges, findings or orders if the licensing authority or a court has dismissed the charges.
